Gentlemen:

On **June 17, 2026**, Sergeant V. Tobar, Booking/Medical Sergeant, was notified by Mr. Collier that personal property inventoried at the time of his incarceration was not provided to him upon transfer to Harris County. Mr. Collier was identified as Inmate **#436052**. Deputies at Harris County reported that no property belonging to Mr. Collier could be located at the time of transfer.

A full review was conducted by the Galveston County Sheriff's Office, documented under **Incident Report Case #26-00002690**. The report states: "An inventory was performed on all inmate property currently stored in the property room; no items belonging to Collier were located anywhere in the property room."

The Sheriff's Office has classified the matter as **Information Only**, with no recovery of the missing property.

Based on the documentation provided and the findings of the Sheriff's Office, it is recommended that Mr. Collier's personal property claim be settled.

RELEASE AGREEMENT

The following agreement is made and entered into by and between CHRISTOPHER COLLIER (hereinafter referred to as "COLLIER") and Galveston County, Texas (hereinafter referred to as "COUNTY"), WITNESSETH:

I.

COLLIER, for himself, or any one claiming through or under his, his heirs, administrators, executors, successors, or assigns, agree to release, and does hereby fully and forever release, acquit and discharge COUNTY, its Commissioners, Boards, elected officials, successors, assigns, agents, servants, employees, and any and all other persons, firms and/or corporations whomsoever from any and all claims or causes of action which COLLIER, for himself or any one claiming through or under his, his heirs, administrators, executors, successors, or assigns, now has or may hereafter have against COUNTY, its Commissioners, Boards, elected officials, successors, agents, servants, employees, and any and all other persons firms and/or corporations whomsoever, in any way arising from or out of any and all property losses and damages now known or that may hereafter develop from that one certain incident which occurred on or about June 02, 2026, wherein COLLIER was released and his personal property was not recovered at the Galveston County Jail.

II.

COUNTY agrees, upon execution of this agreement by COLLIER, to pay or procure to be paid to COLLIER within thirty (30) days from the date of execution thereof by COLLIER the sum of \$1,014.42 for the loss of his personal property that occurred on or about June 02, 2026.

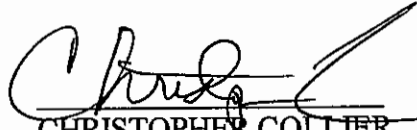
III.

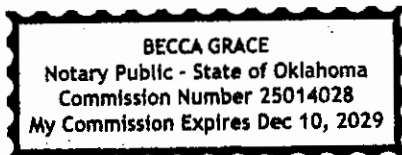

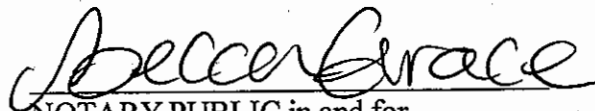

Introduction:

On June 17, 2026 I Sergeant V. Tobar assigned as the Booking/ Medical Sergeant was advised by an individual identified as Collier, Christopher about his missing property that he did not receive when he was transferred/released. The former inmate was identified as Collier, Christopher #436052 was transferred to Harris County and the deputies could not locate any of his property. I was unable to review video due to the time exceeding 30 days in the camera system.

Scene Description:

The Galveston County Jail is located at 5700 Avenue H, Galveston, Texas. Galveston County Jail can hold 1171 inmates.

Details:

On the above date and time, I received information regarding missing property. I attempted to locate the property but was unable to. I received call from Collier regarding the phone in his property. I again attempted to locate the property to no avail, due to the amount of time from entry into the facility has exceed the time frame for the Pelco Camera System.

On June 17- June 23, 2026, an inventoried was performed on all inmate`s property that currently stored in the property room, no items that belonged to Collier was located anywhere in the property room.

On Tuesday June 23, 2026, I contacted Collier and informed him that his property was not located. He was provided the procedure on replacing the property through County Legal. He also provided a copy of the receipt for his lost phone.
