when the following proceedings, among others, were had, to-wit:

Whereas acts of heroism are considered an inspiration to others, it takes certain attributes such as courage and selflessness. Heroism consists of putting others first, even at your peril. Heroism is a concern for other people in need, knowing there is personal risk, done without expectation of reward. Robert Green Ingersoll said it well: "When the will defies fear, when duty throws the gauntlet down to fate, when honor scorns to compromise with death-that is heroism; and

Whereas, on Thursday, May 22nd, 2025, at approximately 2:30 PM, **Deputy Constable Christopher Smith** was dispatched to a call regarding a male struggling in the water near the intersection of HWY 124 and HWY 87; and

Whereas, upon arrival, **Deputy Constable Christopher Smith** located the female caller and the unconscious male in the water, and promptly initiated life-saving measures by pulling the male from the water and administering CPR; and

Whereas, shortly thereafter, **Deputy Constable Richard Loftin** and his wife, **April Loftin**, both licensed paramedics, arrived on the scene and continued the life-saving efforts initiated by **Deputy Constable Christopher Smith**; and

Whereas, thanks to the combined efforts of **Deputy Constable Christopher Smith** and **Deputy Constable Richard Loftin**, the male subject was resuscitated and subsequently administered NARCAN due to indications of opiate use. Despite regaining consciousness, the male subject exhibited violent behavior and required physical restraint to ensure the safety of himself and others; and

Whereas, the actions taken by **Deputy Constable Christopher Smith**, **Deputy Constable Richard Loftin**, and **April Loftin** exemplified exceptional courage, professionalism, and commitment to the health and safety of others; and


