## Memorandum of Understanding

Galveston County Veteran's Treatment Court (GCVTC)

To Whom it may concern:

GULF COAST MONITORING SPECIALISTS (GCMS) acknowledges that the total amount of the proposed AGREEMENT is subject to change, at department's discretion, based on needs and circumstances that arise within the overall DEPARTMENT program. GULF COAST MONITORING SPECIALISTS agrees to the following rates for services:

Installation Fee for any/each device:	\$ 75.00 / each
"SCRAM" Alcohol Ankle Monitoring: Equipment Rental & Monitoring Fee	\$ 11.00 per /day
"SCRAM" with house arrest: Equipment Rental & Monitoring Fee	\$ 12.00 per/ day
GPS Location Tracking: Monitoring Fee	\$ 9.00 per /day
GPS Victim Notification Ally App	\$ 1.00 per/ day
Remote breath/facial recognition/GPS Monitoring:	\$ 6.00 per /day
Drug "Sweat" Patch:	\$ 65.00 / each
Hair Follicle Testing (5 panel)	\$125.00 / each
Hair Follicle Testing (Alcohol)- stand alone	\$150.00 / each
Hair Follicle Testing (combined Alcohol and 5 panel tests	\$224.00 / each

### SERVICES

GCMS shall, in accordance with the terms of this AGREEMENT, provide all necessary personnel, equipment, materials, supplies, facilities, and services and do all things necessary for, or incidentally to, the provision of the services listed above.

GCMS shall assist Defendants to change their behavior and become productive, contributing to members of society by leading a life free of crime.

GCVTC retains control over the Defendants referred to GCMA for the provision of services. If the Defendant is determined to need additional or different services, the Defendant will be referred to the GCVTC for further action.

GCMS agrees to provide testimony in court, if required, at no additional cost to the GCVTC,

#### DUTIES AND OBLIGATIONS

GCMS shall provide the services in compliance with applicable federal and state law, including all constitutional, legal and court-ordered requirements, whether now in effect or hereinafter effected or implemented.

#### CONFIDENTIALITY

When applicable, records of identity, diagnosis, prognosis, or treatment of any Defendant through this proposed AGREEMENT shall be confidential and may be disclosed only in accordance with applicable laws.

#### INSURANCE

GCMS shall obtain and maintain insurance coverage in force in accordance with all applicable law and accepted industry standards during the term they are engaged hereunder. In addition, GCMS shall maintain a liability insurance policy in an amount not less than \$100,000 for each person and \$300,000 for each single occurrence for bodily injury or death and \$100,000 for each single occurrence for injury to or destruction of property.

#### MONTHLY INVOICE

GCMS will bill monthly based on agreed-upon daily rates.
