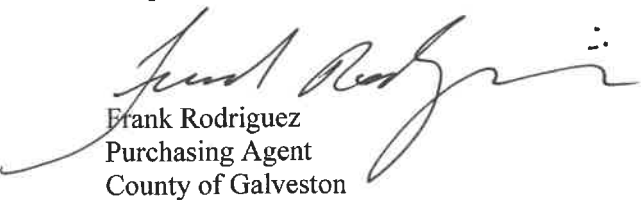
Proposals for RFP 26-092 Electrical and Network Wiring Services were opened on May 28, 2026. Two (2) submittals were received from the following companies:
