Whereas, Jerry Mohn recently announced his retirement from The West Galveston Island Property Owners Association (WGIPOA) a non-profit volunteer organization. He served as president for twenty-six years, and under his direction, has been able to improve and preserve the Island's coastal environment for all west end residents; and

Whereas, Jerry Mohn founded The West Galveston Island Property Owners Association (WGIPOA) in 1999 to be the voice for the communities of Galveston's west end after tropical storm Francis. As a result of his continued diligent work as president, his organization, The West Galveston Island Property Owners Association (WGIPOA) has made numerous monetary donations to organizations responsible for ensuring the socioeconomic and environmental health of Galveston Island. **Jerry Mohn** has striven to enhance the quality of life for all west end residents by promoting responsible development while helping to preserve and protect the Island's coastal marine environment. **Jerry Mohn** was instrumental in forming the Beach Maintenance Advisory Committee of the Parks Board and served 3 consecutive 2-year terms. As a board member of the American Shore and Beach Preservation Association (ASPBA) **Mr. Mohn** not only impacted Galveston but the entire coast of Texas and beyond. He is a lifelong member of Rotary and Ronald McDonald House; and


Whereas, Jerry Mohn has provided excellent leadership to The West Galveston Island Property Owners Association (WGIPOA) in holding monthly meetings with key government (City, County, State) and industry officials to discuss issues, exchange ideas, and communicate needs to enhance the quality of life across West Galveston Island. As a result of **Mr. Mohn's** diligent work with the GLO, he was able to accomplish a massive \$40 million dune construction and sand nourishment program from West of the Seawall to 13 Mile Road.


