#### Introduction

The purpose of this funding is to support projects that promote public safety, reduce crime, and improve the criminal justice system.

#### Certifications

#### **Uniform Crime Reporting (UCR)**

Eligible applicants operating a law enforcement agency must be current on reporting complete UCR data and the Texas specific reporting mandated by 411.042 TGC, to the Texas Department of Public Safety (DPS) for inclusion in the annual Crime in Texas (CIT) publication. To be considered eligible for funding, applicants must have submitted a full twelve months of accurate data to DPS for the most recent calendar year by the deadline(s) established by DPS. Due to the importance of timely reporting, applicants are required to submit complete and accurate UCR data, as well as the Texas-mandated reporting, on a no less than monthly basis and respond promptly to requests from DPS related to the data submitted.

# Entities That Collect Sexual Assault/Sex Offense Evidence or Investigate/Prosecute Sexual Assault or Other Sex Offenses

In accordance with Texas Government Code, Section 420.034, any facility or entity that collects evidence for sexual assault or other sex offenses or investigates or prosecutes a sexual assault or other sex offense for which evidence has been collected, must participate in the statewide electronic tracking system developed and implemented by the Texas Department of Public Safety. A law enforcement agency in possession of a significant number of Sexual Assault Evidence Kits (SAEK) where the 30-day window has passed may be considered noncompliant.

#### **DNA Testing of Evidentiary Materials**

When funds are used for DNA testing of evidentiary materials, any resulting eligible DNA profiles must be uploaded to the Combined DNA Index System (CODIS) by a government DNA lab with access to CODIS.

#### **Interoperable Communications**

Funds to support emergency communications activities must ensure compliance with the FY 2018 SAFECOM Guidance on Emergency Communications Grants; adherence to the technical standards set forth in the FCC Waiver Order, or any succeeding FCC orders, rules, or regulations pertaining to broadband operations in the 700 MHz public safety band; and are fully coordinated with the full-time Statewide Interoperability Coordinator (SWIC) for Texas.

#### **Twelve-Step Programs**

Grant funds may not be used to support or directly fund programs such as the Twelve Step Program which courts have ruled are inherently religious. PSO grant funds cannot be used to support these programs, conduct meetings, or purchase related materials.

#### **Program Income**

Applicant agrees to comply with all federal and state rules and regulations for program income and agrees to report all program income that is generated as a result of the project's activities. <u>Asset Seizures and Forfeitures</u> - Program income from asset seizures and forfeitures is considered earned when the property has been adjudicated to the benefit of the plaintiff (e.g., law enforcement entity).

#### **Project Abstract:**

Public Safety Dive Teams are underwater crime scene experts. They use specialized equipment, have highly specialized training, and use specialized search techniques in order to locate, retrieve, collect, report and maintain chain of custody of evidence which leads or aids in criminal prosecution. Public Safety Divers work in low to zero visibility water, which is majority of the time contaminated with either biological or chemical substances and precautions must be taken to keep the diver safe. Without the specialized equipment or specialized training Public Safety Divers could not do their job efficiently or effectively.

### **Problem Statement:**

The Galveston County Sheriff's Office Dive Team has been neglected for close to a decade. The full-face masks used on every dive operation is designed to keep the contaminated water out of the diver's eyes, nose and mouth. The full-face mask also houses an underwater communication system which allows the diver to communicate to another diver and/or to other members of the Team on the topside. Currently the full-face masks the Sheriff's Office owns are over 15 years old; purchased in 2009, and to utilize the full-face mask specialized industry approved training must be completed and the diver certified in its use. After 3 years of requesting training, finally 4 divers out of 9 were approved to receive the training back in 2023. Another key piece of specialized equipment used by Public Safety Divers is a dry suit. A specialized dry suit with a chemical coating to keep off the biological and chemicals that pollute our waterways. The dry suit fully encapsulates the driver so the only thing exposed

are the face and hands. Once the full-face mask is donned and gloves, the diver is now fully protected from the biological and chemical hazards of the water. The typical life span of a dry suit is 3 to 5 years, the Sheriff's Office currently has dry suits in the 7 to 8-year-old range. The last dry suit purchase made the Sheriff's Office was in 2018, we purchased 2 dry suits. Also, a dry suit needs to fit the diver properly to avoid accidents and injuries to the diver. An ill fitted dry suit can lead to serious injuries and even death. Currently the Sheriff's Office has 4 dry suits and 1 cannot be used due to a broken neck seal that must be sent back to the manufacturer for repair. Also, before a diver can be deployed in a dry suit, more specialized training must be conducted, as is the industry standard and the diver must be certified to wear a dry suit underwater. The specialized training a Public Safety Diver must go through is the industry standard. The diver must first be Open Water certified. This teaches the basic skills of SCUBA diving along with an online learning course. The next phase of training is an Advanced Open Water diving certification which builds on the skills of the Open Water class, but adds in a deep dive to 100 feet, a night or low visibility dive and an underwater navigation are the 3 industry standard dives along with 3 additional elective dives and an online learning course. The Rescue Diver certification is a very important skill, asset and certification to possess. It builds upon the OW and AOW certifications, building confidence in oneself and in skills possessed. A rescue certified diver is capable of managing risks and effectively handling limited in-water problems and diving emergencies. Rescue divers learn how to assist and transport divers, how to perform surface rescues and rescues from depth involving both boat and shore-based skin and SCUBA divers. CPR, first-aid and oxygen administration are required to complete the Rescue Diver certification course. The Diver First-Aid (DFA) course covers CPR; both one- and two-person, basic first-aid techniques commonly encountered while diving, rescue breathing techniques, AED administration and oxygen delivery to injured divers. First aid for diving injuries is different than regular first aid due to the possibility and exposure of nitrogen bubbles in the blood and water in the lungs. There is also an online learning course before doing a hands-on exercise in the water. The diver must be recertified every 2 years as is the industry standard. The last CPR/AED and O2 certification class the Sheriff's Office Dive Team attended in 2022, the Team members had to pay for on their own. The diver will also need to be full-face mask and dry suit certified, as mentioned earlier. Each one has its own online course and in the water drills before certification is complete. The Public Safety Diver course introduces the fundamental skills required by Public Safety Divers during underwater searches, rescues and recovery operations. The PSD course builds the confidence of the diver in utilizing search patterns in zero visibility water and having the confidence to trust the search pattern along with the top-side personnel who is controlling the search pattern. The PSD course teaches rope or line signals, should underwater communications fail, how to collect evidence underwater and maintain evidentiary chain of custody. The PSD course also teaches various other techniques in body recoveries, vehicle recoveries, underwater metal detecting and so much more. There is also an online learning course before conducting any in the water exercises. Currently the Sheriff's Office has 9 divers and 3 are PSD certified. The 3 PSD certified divers had to pay for the certification themselves.

#### **Supporting Data:**

Galveston County is almost 50% water. It borders with the Gulf of Mexico, various creeks, bayous, lakes, ponds, retention

ponds and any other body of water within the County and having a specialized team capable of entering the water safely, to retrieve evidence from the bottom of the water only aids in the criminal prosecution. The Dive Team has even been requested by other Counties (Brazoria and Harris), other Law Enforcement Agencies (Galveston PD, League City PD, Dickinson PD, Hitchcock PD, Texas City PD, La Marque PD, Santa Fe PD, Lake Jackson PD, TDCJ, Texas Rangers; just to a name a few agencies) and even some Federal taskings (DEA, FBI, NASA, Coast Guard and US Army) to locate, collect and retrieve evidence in the water. The Dive Team has been to another State to locate, collect and retrieve evidence. In order to retrieve the evidence from the bottom, divers must go through specialized training; as mentioned earlier and utilize specialized equipment to keep the diver safe from the biological and chemical hazards found in the waterways. The diver must have the confidence, and the certification to perform his/her job safely, efficiently and effectively. Currently the Galveston County Sheriff's Office Dive Team is ill-equipped as the full-face masks are over 15 years old, dry suits that are past their expected life span and the Team lacks the required industry standard certifications to deploy divers into the water. For the past decade, except for two instances, members of the Dive Team have paid for their own certifications.

#### **Project Approach & Activities:**

First priorities will be to purchase new dry suits that fit the diver. Then purchase new full-face masks to update the antiquated 15-year-old masks and underwater communications currently being used. After the specialized equipment has been purchased Team members will then be certified, industry standard, in the use of the equipment. Team members must be certified in this specialized equipment before proceeding to the next certification level and ultimately becoming Public Safety Divers. Every team member will go through the top-side support specialist (TSS) course which is designed to teach either a diver or a nondiving team member their vital role on a public safety dive team. The TSS plays a vital role in the diver's well-being, effectiveness and the success of the mission. The TSS is a key member of the team, and this course teaches them how to be successful at their job. The TSS will learn search and recovery dive planning, organization, procedures, techniques and how to deal with potential problems. How to interview witnesses, how to document the dive operation and most importantly how to keep the entire team safe. Then introduce the divers to this highly specialized course, the Underwater Criminal Investigator (UCI) course. The UCI is foundation course. It is designed to give the diver the knowledge, skills, confidence, and abilities to succeed and survive as a true professional Underwater Criminal Investigator. After UCI, The Master UCI Course builds off the basic UCI course and is focused on advanced techniques specialized for Law Enforcement Diving Specialists. The Master UCI Course expounds upon underwater body recovery techniques, underwater vehicle search and recovery techniques and underwater evidence recovery techniques but at an advanced level. After completing the course, the diver will be certified and specialized in Body Recovery Specialist, Vehicle Recovery Specialist, Evidence Recovery Specialist, CSI Metal Detector Specialist and will be a Master Underwater Criminal Investigator. The plan is to send several divers to the Public Safety Diver Commander Course which is designed to prepare the person in charge of the dive team the legal, responsibility and ethics of being in charge of a dive team. It prepares the Team Commander for team organization, team member selection, team activities and team performance. The Commander is also responsible for record keeping, not just in training but also in equipment maintenance. The course also covers risk management, diver safety, dive mission, managing a dive team, conducting dive briefings and debriefings, managing a dive medical emergency, risk/liability reduction, dive operation case review, search pattern set-up and

a lot more. Another piece of highly specialized equipment will be an Underwater ROV, specifically the SARbot (Search and Rescue robot) is a surface powered easy-to-operate, robotic system which is optimized for underwater search and recovery operations in low-visibility conditions. The underwater ROV would also be another great asset or tool utilized by the dive team. A robot does not get tired, it does not get sick, it does not get cold and it does not require air to stay underwater. The use of the robot would minimize the exposure of the diver to the contaminated water. Granted, the diver will still have to go in and recover the evidence, document it, collect it, and maintain the chain of custody. The robot would just be the tool utilized to locate the evidence; situation dependent. As pointed out, the dive team is in dire need of some specialized training and equipment. This specialized training will not only make the team better but also lower the Agency's liability. This specialized training will boost the confidence of the team members, making them more successful, increasing their efficacy and making us an even more of a valuable asset to not only this Agency, but other agencies within and around Galveston County but also to the citizens of Galveston County.

#### Capacity & Capabilities:

The history of the Dive Team started just prior to 1992 with just two "off-duty" Deputies who were SCUBA certified. In 1996, the Dive Team became more official and was made up of "full-time" deputies and the Sheriff's Office purchased dry suits for the divers. In 1998 the Dive Team moved under the direction and guidance of the Marine Division and the Marine Division Commander. In 2000, the Dive Team made a substantial change, and a purchase was made for full-face masks and switched to the Life Guard Systems (LGS) certification. In 2001 another purchase was made for underwater communications with buddy phones for the full-face masks and a top side communication unit. In 2003 the Sheriff's Office completed a transition to all Agency owned dive gear. In 2004 the dive team made another transition from regular SCUBA gear to a surface supply system with bail-outs. In 2007 new dry suits were purchased along with some more surface supply items to augment what was previously purchased. Since I have taken over as the Lead in 2018, we have transitioned back to regular SCUBA and no longer rely on the LGS certification. I have also gone out on my own and became a certified Dive Master and even obtained a SCUBA Dive Instructor, PSD Instructor and a DFA Pro (Diving First Aid for Professionals) Instructor. No other major purchases have been made aside from two dry suits in 2018, three regulator sets in 2021, one additional regulator set in 2023 and a tank fill whip in 2024. After three years of continuously applying for training, I was finally able to get four divers full-face mask certified in 2023. As you can see from the history of the dive team, we have gone without the necessary and required training certifications and equipment for years. Two team members have even gone out on their own and paid for some of the specialized training required. The required basic training certifications are for specialized equipment used on almost every dive operation. Having certified divers; certified, confident, and qualified in the use of specialized equipment minimizes the Agency's liability, and not to mention it is also the industry standard. Either way, we still manage to show up when called out, not just for our Agency, but also for surrounding Agencies and surrounding Counties, as well as some Federal Agencies have requested our assistance. The Dive Team has even been to another state, Louisiana, for an operation. The Dive Team averages twelve callouts a year, and we currently train once a month. Being a Public Safety Diver is a very small niche within Law Enforcement and this type of specialization is not for everyone.

### Performance Management:

Success will be measured by obtaining the required specialized equipment used on every dive operation and required specialized training for the remaining divers on the team, Public Safety Divers. The overall goals will be to obtain the required industry standard certifications in order. Before that can be accomplished the required specialized equipment must be obtained. Divers as they progress through the certifications will be issued certifications and cannot progress to the next certification without completing the current specialized training. Each specialized course also has an online learning component with a graded test that must also be passed before continuing on to the in-water portion of the specialized training. Divers can print out a successful completion certificate once the online learning component is completed and passed. Should a diver need remedial training, that can also be accomplished to obtain a successful pass rate. Every diver operation is also documented with an incident number or a supplemental case report and external dive reports are then attached to the report. The underwater ROV, when requested, will also be documented with an incident number and a specialized dive team equipment report.

#### **Evidence-Based Practices:**

The methods, approach and activities described above are the industry standard, not just nationally but internationally recognized standards as it pertains to Public Safety Diving. Public Safety Diving is a mix of recreational diving and commercial diving. Below is an exert from the NAUI (National Association of Underwater Instructors) 2025 Standards and Procedures as it pertains to Public Safety Diving certification course: NAUI is an internationally recognized SCUBA diving certifying agency. It is also used by the US military as a certifying agency as it pertains to military dive operations. "Policies Applying to All Public Safety Diver Training Courses OVERVIEW AND QUALIFICATIONS NAUI Public Safety Diver courses emphasize safety; knowledge; skill; abilities; and risk, incident, and resource management with practical applications. The course is also designed specifically to provide public safety divers with training, knowledge, and skills necessary to assist them during Public Safety Dive Operations and the activities commonly associated with them.
