AMENDMENT TO INTERLOCAL CONTRACT

Amendment Number 1

THIS INTERLOCAL AMENDMENT is made by and between the State of Texas acting by and through the Texas Department of Transportation, (TxDOT), and Galveston County (Local Government), and shall become effective when fully executed by both parties.

BACKGROUND

The TxDOT and the Local Government executed a contract on February 27, 2024, concerning providing uniformed, armed peace officers and equipment for law enforcement, general surveillance, and traffic control.

It is mutually understood and agreed by and between the undersigned contracting parties to the above numbered Interlocal Contract to amend the contract as follows:

AGREEMENT

Article IV, CONTRACT PAYMENT is deleted and replaced with "The total amount of this contract shall not exceed \$968,492.00 and shall conform to the provisions of Attachment B-1, Budget. Payments shall be billed monthly.

Article V. TERM OF CONTRACT: The agreement is extended from February 26, 2025, to February 25, 2026, in order to utilize the one-year renewal option.

Attachment B, Budget, is deleted in its entirety and replaced with Attachment B-1, Budget, which is attached to and made part of this amendment. The budget increased by \$485,574.00 from \$482.918.00 to \$968,492.00, due to adding another year to the contract, increase in pay rates, and total hours.

All other terms and conditions of the above numbered Interlocal Contract not hereby amended remain in full force and effect.
