Description Commissioner Apffel- Request transfer from budgeted reserves to IT other contract services for Liberty Tech is currently providing interim cloud hosting services for the CoreEMR application and database during the transition of services to UTMB. This proposal includes both the migration

and ongoing monthly hosting fees associated with relocating the CoreEMR instance from VitalCore's infrastructure to Galveston County's hosting environment. CoreEMR is a proprietary system utilized to intake patients at the jail and to manage medical records, treatment plans, and ongoing care throughout an individual's time in custody. As the application can only be supported by the vendor's technical staff, professional services from CoreEMR are required to complete the migration. The hosting arrangement includes a dedicated secure server with comprehensive support,

encryption, and cybersecurity measures.

Summary

CorEMR Server Hosting and Support

Liberty Technical Solutions (Liberty Tech) will provide a hosted environment for the deployment of CorEMR. It will be built in the Microsoft Azure datacenter environment in a Galveston County tenant, under the management of LibertyTech. Included is SFTP server software to facilitate encrypted transfer of data from the Jail Management System (JMS), along with an SSL certificate for encrypted access to the system.

We are including pricing for one server, which will serve as both the application server and a database server. This complies with CorEMR's recommendations for a facility of this size and provides room for storage of historical data.

Additionally, included is the LibertyTech monthly server support and cyber defense plan. It covers 24/7 monitoring and remediation, automated system patching, antivirus, enterprise grade cybersecurity protection, file and database backup, and management and remediation labor.

Azure pricing is based on Microsoft's Azure Pricing Calculator (https://azure.microsoft.com/en-us/pricing/calculator). Any adjustments required by CorEMR will be billed accordingly.

All staging and go-live services are billed at Time & Materials cost. Our labor rate is \$190/hr. We have included a 'minimum' and a 'not-to-exceed' amount. The 'not-to-exceed' amount is a buffer to not exceed without written approval. In some cases, the scope of work expands during the project, and it becomes necessary to make an adjustment. However, those adjustments will not be made without written approval for the additional work and subsequent cost.
