I hope this message finds you well. On behalf of the M.I. Lewis Social Service Center, I am writing to formally request a second round of funding for the FY25 Emergency Financial Assistance contract period.

We are seeking \$40,000 to continue providing urgent support to Galveston County residents in crisis. Of this amount, \$36,363.64 will be used directly for client assistance, with 10% (\$3,636.36) allocated toward administrative costs associated with delivering services.
