

AMENDMENT #1 TO THE FOOD SERVICE AGREEMENT

This Amendment is made and entered into by and between Galveston County ("Client"), and Summit Food Service, LLC ("Company") (collectively "the Parties").

WHEREAS, the Parties have entered into a certain Food Service Agreement (the "Agreement"), effective September 1, 2024;

WHEREAS, the Parties have agreed to adjust pricing for the Agreement; and

WHEREAS, the Parties now desire to amend said Agreement upon the terms and conditions stated herein.

NOW, THEREFORE, the Parties, intending to be legally bound hereby, mutually agree as follows:

1. **Payment Arrangement.** Due to a change in menu for the period running March 28, 2025 to May 6, 2025, the parties have agreed that Client shall pay to Company an additional \$0.89 per meal served. Company shall issue a one-time invoice to the Client, separate from the standard invoice, for the additional cost. The amount to be invoiced to the Client totals \$120,743.63. Exhibit A, attached hereto, shows the breakdown of meals that were served per day.

This Amendment is effective as March 28, 2025. All other terms and conditions of the original Agreement (as modified from time to time) shall remain in full force and effect unless otherwise amended as provided in the Agreement.
