BACKGROUND

In response to the July 7, 2016 shooting incident in Dallas, the Texas Legislature passed Senate Bill 12, which created a grant program to increase the safety of Texas Law Enforcement officers by assisting agencies in the purchase of rifle-resistant body armor.

SUMMARY

Galveston County endeavors to purchase 25 ballistic vests and 50 plates to provide for officers not equipped last year and new officers added over the last year.

Introduction

The Rifle-Resistant Body Armor Grant Program supports equipping law enforcement officers at risk of shootings with rifle-resistant body armor.

NIJ Body Armor Standards

Applicant assures that body armor purchased with grant funds will comply with the [National Institute of Justice \(NIJ\) standard \(Ballistic Resistance of Body Armor NIJ Standard - 0101.06\)](#) for type III (rifles) or type IV (armor piercing rifle) body armor, including bullet-resistant vests, ballistic plates, and plate carriers.

Personally Fitted Vest Requirement

Applicant assures that all body armor vests purchased with grant funds will be personally fitted for individual officers, including vests specifically fitted to individual female law enforcement officers. "Personally fitted" does not require armor be individually manufactured based on the measurements of a specific wearer, but rather that it provide the best possible fit and coverage, through a combination of:

1. Correctly-sized panels and carrier, determined through appropriate measurement; and
2. Properly adjusted straps, harnesses, fasteners, flaps, or other adjustable features.

The American Society for Testing and Materials (ASTM) International has made available the Standard Practice for Body Armor Wearer Measurement and Fitting of Armor ([Active Standard ASTM E3003](#)) available at no cost. The Personal Armor Fit Assessment [checklist](#), is excerpted from ASTM E3003.

Resolution from Governing Body

Applications from nonprofit corporations, local units of governments, and other political subdivisions must submit a fully executed resolution with the application to be considered eligible for funding. The resolution must contain the following elements (see [Sample Resolution](#)):

- Authorization by your governing body for the submission of the application to the Public Safety Office (PSO) that clearly identifies the name of the project for which funding is requested;
- A commitment to provide all applicable matching funds;

Criminal History Reporting

Entities receiving funds from PSO must be located in a county that has an average of 90% or above on both adult and juvenile dispositions entered into the computerized criminal history database maintained by the Texas Department of Public Safety (DPS) as directed in the *Texas Code of Criminal Procedure, Chapter 66*. The disposition completeness percentage is defined as the percentage of arrest charges a county reports to DPS for which a disposition has been subsequently reported and entered into the computerized criminal history system.

Counties applying for grant awards from the Office of the Governor must commit that the county will report at least 90 percent of convictions within five business days to the Criminal Justice Information System at the Department of Public Safety.

Uniform Crime Reporting (UCR)

Eligible applicants operating a law enforcement agency must be current on reporting complete UCR data and the Texas specific reporting mandated by 411.042 TGC, to the Texas Department of Public Safety (DPS) for inclusion in the annual Crime in Texas (CIT) publication. To be considered eligible for funding, applicants must have submitted a full twelve months of accurate data to DPS for the most recent calendar year by the deadline(s) established by DPS. Due to the importance of timely reporting, applicants are required to submit complete and accurate UCR data, as well as the Texas-mandated reporting, on a no less than monthly basis and respond promptly to requests from DPS related to the data submitted.

Entities That Collect Sexual Assault/Sex Offense Evidence or Investigate/Prosecute Sexual Assault or Other Sex Offenses

In accordance with Texas Government Code, Section 420.034, any facility or entity that collects evidence for sexual assault or other sex offenses or investigates or prosecutes a sexual assault or other sex offense for which evidence has been collected, must participate in the statewide electronic tracking system developed and implemented by the Texas Department of Public Safety. Additionally, per Section 420.042 "A law enforcement agency that receives evidence of a sexual assault or other sex offense...shall submit that evidence to a public accredited crime laboratory for analysis no later than the 30th day after the date on which that evidence was received." A law enforcement agency in possession of a significant number of Sexual Assault Evidence Kits (SAEK) where the 30-day window has passed may be considered noncompliant.

Compliance with State and Federal Laws, Programs and Procedures

Lastly, eligible applicants must comply with all provisions, policies, and penalties found in Chapter 752, Subchapter C of the Texas Government Code.

Each local unit of government, and institution of higher education that operates a law enforcement agency, must download, complete and then upload into eGrants the [CEO/Law Enforcement Certifications and Assurances Form](#) certifying compliance with federal and state immigration enforcement requirements. Project Abstract :

Galveston County is dedicated to protecting its 320 peace officers through the systematic provision of high-quality, rifle-resistant body armor. Our jurisdiction faces complex security challenges, ranging from the continuous protection of nationally significant critical infrastructure—including the Houston Ship Channel and the country's third-largest refinery, where the threat of high-velocity weaponry is a constant reality—to responding to intermittent and unexpected high-intensity violence, such as the Santa Fe School Shooting. To maintain maximum safety standards in this high-stakes, dynamic environment, the County utilizes a rolling replacement strategy that relies on grant partnerships to ensure no officer is forced to rely on rifle-resistant body armor exceeding its five-year manufacturer-rated lifespan. This FY27 proposal represents the next critical phase of this long-term safety initiative, which has been successfully sustained through previous funding cycles in 2018, 2020, FY25, and FY26. The requested funds will replace armor components issued in 2022 that reach expiration in 2027. Without this continued state support, the County would face a significant budgetary gap in replacing these essential life-saving components. Ultimately, this funding partnership is a critical investment in the men and women who protect Galveston County, ensuring that those standing on the front lines against violent threats are never left without the highest standard of life-saving ballistic protection.

Problem Statement :

The Santa Fe School Shooting underscored a definitive reality: our officers must maintain a constant state of readiness to counter high-velocity threats and large-scale violent incidents. Galveston County operates within a multifaceted and high-stakes security landscape where 320 peace officers are increasingly exposed to high-velocity weaponry during routine patrols, specialized responses, and the constant protection of nationally significant critical infrastructure. This includes the Houston Ship Channel and the country's third-largest refinery, where the threat of high-powered ballistics is a constant operational reality. The primary challenge addressed by this project is the technical and structural degradation of life-saving equipment over time. Standard-issue soft armor is inherently insufficient against the high-powered rifles prevalent in modern domestic threats. While specialized rifle-resistant plates provide the necessary defense, they carry a strict five-year manufacturer-rated lifespan. Beyond this window, ballistic integrity can no longer be guaranteed, creating a critical vulnerability for officers deployed into high-threat environments. Current budgetary constraints make it difficult to sustain the high costs of specialized equipment through general funds alone. Without a systematic, rolling replacement strategy supported by grant partnerships, the County faces the risk of officers relying on expired or compromised armor. By aligning our procurement with manufacturer lifecycles, this project ensures that equipment failure is never the reason an officer loses their life in the line of duty.

Supporting Data :

In 2017, Galveston County was one of 29 jurisdictions recognized by the US Department of Homeland Security for grant funds due to our target-rich environment. Our placement along the intersection of the Houston Ship Channel, the Gulf Intercoastal Waterway, TxDOT Ferry Service and the Galveston Harbor combined with our highly-populated events such as serving 1 million/year cruise tourists, 500,000+ tourist events such as the Lone Star Motorcycle Rally and Mardi Gras puts our law enforcement officers on alert on multiple fronts. These events plus the placement of the third largest refinery in the nation and a Level IV Laboratory put Galveston County on watch for terrorist attacks and high-population target events.

Project Approach & Activities:

To address the critical safety gap identified in the Problem Statement, Galveston County seeks to implement a structured Life-Cycle Management Program specifically for the provision of rifle-resistant body armor. The project's methodology focuses on a transition toward a proactive procurement strategy; however, current local funding is insufficient to cover the high costs of specialized ballistic plates. This grant serves as the essential mechanism to ensure 100% of our force is equipped with reliable, current-rated protection that would otherwise remain financially out of reach. The project will utilize a phased procurement approach to replace specialized rifle-resistant body armor for those units that have already expired or are scheduled to exceed their manufacturer-rated lifespan throughout the grant period. This approach is dictated by manufacturer-certified safety standards, which state that ballistic integrity cannot be guaranteed beyond a five-year window. Without the infusion of grant funds, the county remains unable to reconcile the gap between these strict safety standards and the reality of our current aging inventory over the term of the project.

Capacity & Capabilities:

Galveston County possesses the administrative infrastructure and operational expertise necessary to successfully execute this equipment-purchase project. The project will be managed through a collaborative partnership between the Galveston County Sheriff's Office (GCSO) and the County Purchasing Department, ensuring a seamless transition from procurement to field deployment. The Galveston County Purchasing Department is experienced in high-volume, regulated procurement and maintains strict adherence to all local, state, and federal purchasing policies. The Sheriff's Office brings decades of experience in tactical equipment management and officer safety protocols. Galveston County recognizes that to be effective, rifle-resistant body armor must be personally fitted to individual officers to ensure maximum coverage and mobility. Furthermore, the GCSO command staff is committed to safety excellence, requiring that all procured armor meets or exceeds National Institute of Justice (NIJ) Level III or IV ballistic standards. This partnership ensures that the project is supported by both financial oversight and technical expertise. The Sheriff's Office will manage the individualized fitting and inventory tracking, while the Purchasing Department manages the contractual aspects of the grant. Together, these departments have a proven track record of managing similar equipment lifecycles, ensuring this project will be executed on time and within budget.

Performance Management :

The primary goal of this project is to maintain 100% ballistic safety compliance through a proactive, rolling replacement strategy. Success is measured by the department's ability to systematically phase out expiring gear and equip personnel with current NIJ-certified protection without any gaps in coverage. To achieve this, the Galveston County Sheriff's Office will utilize a dynamic equipment-tracking database to manage the lifecycle of all rifle-resistant body armor. This system allows for the continuous collection and maintenance of critical data, including: Inventory Lifecycle Data: Manufacturer serial numbers and certified expiration dates for all components. Deployment Records: Precise date of issuance and documented officer acknowledgement of receipt. Rolling Schedule Audits: Monthly reviews of the assignment list to identify equipment approaching its five-year end-of-life date. The organization will measure success by the successful transition of officers from aging units to new armor according to the established rolling schedule. By tracking these specific data points, the County ensures that no officer is deployed with expired protection and that all grant-funded assets are accurately accounted for. This ongoing data maintenance provides a clear, audit-ready record of how the project is achieving its safety standards throughout the entire grant period.




