II.

COUNTY agrees, upon execution of this agreement by KARIM, to pay or procure to be paid to KARIM within thirty (30) days from the date of execution thereof by KARIM the sum of \$1,990.00 for the loss of his personal property that occurred on or about November 11, 2025.

III.

KARIM warrants that he is under no incapacity which would render him unable to execute an agreement and make it legally binding.

IV.

Both parties hereto have carefully read and fully understand this agreement, which clearly expresses the entire agreement between them. No representation or promise has been made by either party except as herein stated, and the sole consideration of and for this contract is herein correctly provided.

I also fully understand that all paint jobs require paint correction but that Dip it Good does not provide it and I will have to go to another shop for compound and polishing should I feel the need to take the project a step further to my liking. Making a full payment to services rendered concludes that the job was to my satisfaction.

I hereby release Dip it Good from any and all liability claims, demands, and or legal action caused or related to damages to my vehicle because of said products.
