All increases in the Asphalt Cement Prices at the time of furnishing will be passed through to the Customer. The method of adjustment for the ASB & the Type 'D' mixes will be, as an example, for every \$25.00 increase in the Asphalt Cement price there will be an increase of \$1.50 per ton to our above quoted unit price of hot mix. Our above bid unit prices will not decrease or at any time be lower than the initial bid unit prices above.
