- Notwithstanding anything to the contrary in the Agreement, any references in the Agreement to (i) "TR Group", "Thomson Reuters Group", "Reuters Group" or any other reference to "Group" when used in relation to Refinitiv, shall mean Refinitiv, and any entity that, from time to time, is directly or indirectly controlling, controlled by, or under common control with Refinitiv (including its successors and assigns); and (ii) "Affiliate" when used in relation to Refinitiv and/or Giact, shall mean Refinitiv and/or Giact and any entity that, from time to time, directly or indirectly controls, is controlled by or is under common control with Refinitiv and/or Giact and any entity that, from time to time, directly or indirectly controls, is controlled by or is under common control with Refinitiv and/or Giact (including its successors and assigns). - Client confirms, by signing below, that it has the necessary authority to enter into this Order Form on the terms and conditions set forth in the Agreement.
- This Order Form is binding when countersigned by Client provided that Client has not made any changes to this Order Form. If Client modifies this Order Form this Order Form shall be null and void.
- All Fees shall be billable from the Order Form Effective Date reflected on page 1.
- The pricing currency of each Service on this Order Form is set out above. This may be different from the local billing currency. As a result of exchange rate fluctuations, the figure set out on Client's invoice may vary from one billing period to the next.
- · All Service Fees are exclusive of taxes, third party subscription fees, exchange fees, costs and duties.
- Any information, materials or other services provided by third parties (such as stock exchanges and other information providers)
  provided as an add-on to the Service and/or designated as Related Charges shall, unless otherwise specified in the relevant
  Order Form, be subject to the usage permissions set out in the relevant Schedule for the underlying Service that such information,
  materials or other services are provided in conjunction with.

- In the event of conflict between these Product Notes and the Master Terms or a relevant applicable Schedule, the Product Notes shall govern, save with respect to (i) any conflict between the Product Notes and the Screening Schedule, in which case the terms in the Screening Schedule shall govern; (ii) any conflict between the Product Notes and the Giact Services Schedule, in which case the terms in the Giact Services Schedule shall govern.

# **Risk Services Related Variations to the Master Terms**

- Fees
  - Where the Fees include transaction-based charges as set out on the Order Form or SOW ("Transaction Fees"), GIACT shall provide Client with monthly invoices following the end of each calendar month detailing Client's usage of the Service and the Transaction Fees incurred by Client in the relevant month. All Transaction Fees below paid by Client for the Services throughout the Term will be offset on a dollar for dollar basis against the Monthly Minimum Fee set forth herein and Client shall pay all Transaction Fees in excess of the Monthly Minimum Fee; provided, however, that in no event will any Transaction Fees paid in any month in excess of the Monthly Minimum Fee for that month be applied towards the Monthly Minimum Fee in any other month.  Client certifies that because the information provided in the gldentify Global Services is not consumer report information, Client will not request or use these Services as a factor in establishing a consumer's eligibility for credit or insurance to be used primarily for personal, family, or household purposes, employment purposes, tenant screening, or for any other purpose authorized under the FCRA or similar state or local statute, rules or regulations.

### gldentify Global Services

- The Service includes verification of identity attributes (e.g., name, address, date of birth) against trusted data sources (e.g., Credit Reference Agency or Government Citizen file) ("Verifications").
- The definition of Screening Content in the Screening Schedule includes gldentify Global information contained in the gldentify Global Services.

If Client reasonably objects to a change to the list, at Refinitiv's option Refinitiv will either: (i) give Client an opportunity to pay for a version of the relevant part of the gldentify Global Service without use of the Processor to which Client objects; or (ii) terminate the provision of the affected part of the gldentify Global Service to Client immediately upon notice.
    - Third Party Sub-Processors Engaging Additional Processors.     - Privacy Notice and Consent Requirements. Client will comply with (i) all applicable Data Protection Legislation in connection with providing privacy notices to, and receiving consent from, all data subjects prior to permitting or allowing personal data to be submitted, uploaded, transferred, and/or shared to Giact and its Affiliates and/or the sub-processors (including Third Party Sub- Processors and the Fourth Party Sub-Processors) in connection with the gldentify Global Services and (ii) the notice and consent requirements set forth in the Permitted Purpose and Additional Obligations requirements, if any, as referenced in, the Product Notes section of the Order Form.
    - In the event of a conflict between the terms set forth in these Privacy Product Notes and the terms set forth in any
      other contract documents between Giact and a Client (e.g., Master Terms, Schedules, Order Forms/SOWs, etc.),
      the terms set forth in these Privacy Product Notes will govern and control in all respects.
    - For the purpose of the Services, the term "Data Protection Legislation" shall mean "the following legislation to the extent applicable from time to time: (a) national laws implementing the Directive on Privacy and Electronic Communications (2002/58/EC); (b) the EU General Data Protection Regulation (2016/679) ("GDPR") and any national law issued under that Regulation; and (c) any other national, provincial, federal, state, and/or local data protection and privacy law(s)." Theforegoing definition shall govern and control over any other definitions provided by Data Protection Legislation.
  - gldentify Global Permitted Usage Terms
    - Except where usage rights are further limited in jurisdictions identified herein, Client is permitted to use Giact's gldentify Global Services for the purpose of verifying or validating an individual's or natural person's identity, age, or address information for lawful purposes of identity verification, fraud prevention or enforcement of laws designed to prevent money laundering, but does not include determining a consumer's eligibility for credit or insurance for personal, family, or household purposes, employment, or a government license or benefit ("Permitted Purposes"). Client agrees that new jurisdictional restrictions may apply over time. At all times, Client shall comply with any Data Protection Legislation applicable in any jurisdiction relevant to Client's use of the Services.

#### Non Standard Terms and Conditions

Texas Prompt Payment Act: Payments, invoicing, disputes, and interest shall be governed by the Texas Prompt Payment Act, Texas Government Code Chapter 2251, as amended. The parties agree that any provisions related to payment timing, interest on late payments, or invoice disputes shall be interpreted in accordance with said statute.

Confidentiality: The parties acknowledge and agree that the existence and terms of this Agreement may be subject to public disclosure requirements under applicable open records laws or public information acts. However, any proprietary or confidential information provided by

Refinitiv, whether or not incorporated into this Agreement, shall remain confidential and shall not be subject to public disclosure.

Indemnification: Notwithstanding anything to the contrary in the Agreement, to the extent permitted by applicable law, the indemnification obligations set forth therein shall not apply to Galveston County.

Early Termination: Client may terminate this Agreement, without penalty, effective at the end of any Client fiscal year in which its governing body fails to appropriate sufficient funds to satisfy Client's payment obligations for the next fiscal year, provided that:

- (a) Client gives Refinitiv written notice of termination no later than the end of such fiscal year;
- (b) such notice specifies the fiscal year-end effective date; and
- (c) Client remains liable for Fees accrued, on a pro-rata basis, for Services delivered up to that effective date.

The parties will cooperate for up to thirty (30) days after such termination to facilitate an orderly transition or wind-down of the affected Services.

This Order Form and the Agreement will be governed by and construed in accordance with the laws of the State of Texas, without giving effect to the State of Texas conflict of laws rules to the extent those rules would require applying another jurisdiction's laws. Each party hereby consents to the non-exclusive jurisdiction of the federal and state courts in Texas to settle all disputes or claims arising out of or in connection with the Agreement.
