### Background

The Texas Office of the Governor (OOG), Public Safety Office (PSO) administers the FY26 Bullet-Resistant Components for Law Enforcement Vehicles Grant. This dedicated state funding opportunity was created to enhance the safety of local peace officers across Texas, building upon prior state efforts to equip agencies like the Texas Department of Public Safety with ballistic vehicle protection. The grant's specific purpose is to equip motor vehicles used by peace officers with essential bullet-resistant components.

### Summary

The Sheriff's Office seeks grant funding to install NIJ Level IIIA or higher certified bullet-resistant components in patrol vehicles utilized by the County's law enforcement agencies. The primary objective is to significantly enhance officer safety and survivability for deputies operating in high-threat environments, such as ambushes and critical incidents. This vital protective upgrade will be implemented for the Sheriff's Office, the Constable's Office, and the Criminal District Attorney's Office Investigative Division upon receipt of award.

Ratification of this application is requested to confirm submission made in coordination with the OOG, PSO to meet the state application deadline, and to authorize the County Judge to execute all related documents.

**Introduction**

The purpose of this funding is to provide grants to law enforcement agencies to equip motor vehicles used by peace officers with certain bullet-resistant components.

**Certifications**

In addition to the requirements found in existing statute and regulation, this program requires applicant organizations to certify compliance with the following:

#### **Constitutional Compliance**

Applicant assures that it will not engage in any activity that violates Constitutional law including profiling based upon race.

#### **Cybersecurity Training Requirement**

Local units of governments must comply with the Cybersecurity Training requirements described in Section 772.012 and Section 2054.5191 of the Texas Government Code. Local governments determined to not be in compliance with the cybersecurity requirements required by Section 2054.5191 of the Texas Government Code are ineligible for OOG grant funds until the second anniversary of the date the local government is determined ineligible. #### **Criminal History Reporting**

Entities receiving funds from PSO must be located in a county that has an average of 90% or above on both adult and juvenile dispositions entered into the computerized criminal history database maintained by the Texas Department of Public Safety (DPS) as directed in the *Texas Code of Criminal Procedure, Chapter 66*. The disposition completeness percentage is defined as the percentage of arrest charges a county reports to DPS for which a disposition has been subsequently reported and entered into the computerized criminal history system.

Counties applying for grant awards from the Office of the Governor must commit that the county will report at least 90 percent of convictions within five business days to the Criminal Justice Information System at the Department of Public Safety.

#### **Uniform Crime Reporting (UCR)**

Eligible applicants operating a law enforcement agency must be current on reporting complete UCR data and the Texas specific reporting mandated by 411.042 TGC, to the Texas Department of Public Safety (DPS) for inclusion in the annual Crime in Texas (CIT) publication. To be considered eligible for funding, applicants must have submitted a full twelve months of accurate data to DPS for the most recent calendar year by the deadline(s) established by DPS. Due to the importance of timely reporting, applicants are required to submit complete and accurate UCR data, as well as the Texas-mandated reporting, on a no less than monthly basis and respond promptly to requests from DPS related to the data submitted.

#### **Entities That Collect Sexual Assault/Sex Offense Evidence or Investigate/Prosecute Sexual Assault or Other Sex Offenses**

In accordance with Texas Government Code, Section 420.034, any facility or entity that collects evidence for sexual assault or other sex offenses or investigates or prosecutes a sexual assault or other sex offense for which evidence has been collected, must participate in the statewide electronic tracking system developed and implemented by the Texas Department of Public Safety. Visit DPS's [Sexual Assault Evidence Tracking Program](#) website for more information or to set up an account to begin participating. Additionally, per Section 420.042 "A law enforcement agency that receives evidence of a sexual assault or other sex offense...shall submit that



evidence to a public accredited crime laboratory for analysis no later than the 30th day after the date on which that evidence was received." A law enforcement agency in possession of a significant number of Sexual Assault Evidence Kits (SAEK) where the 30-day window has passed may be considered noncompliant.

#### **Compliance with State and Federal Laws, Programs and Procedures**

Local units of government, including cities, counties and other general purpose political subdivisions, as appropriate, and institutions of higher education that operate a law enforcement agency, must comply with all aspects of the programs and procedures utilized by the U.S. Department of Homeland Security ("DHS") to: (1) notify DHS of all information requested by DHS related to illegal aliens in Agency's custody; and (2) detain such illegal aliens in accordance with requests by DHS. This Form is required for each application submitted to PSO and is active until August 31, 2026 or the end of the grant period, whichever is later.

#### **Project Abstract :**

The County of Galveston—including the Galveston County Sheriff's Office, Constable Precincts 1–4, and the Galveston County Criminal District Attorney's Office Investigative Division—seeks funding to equip 88 patrol and investigative vehicles with bullet-resistant components to protect law enforcement personnel from firearm assaults and ambush attacks. In alignment with state priorities, this project advances the Governor's focus on enhancing officer survivability and strengthening operational resilience during violent encounters. Moreover, the initiative is fully scalable, allowing implementation at varying funding levels. Specifically, the full "DPS" ballistic package provides comprehensive protection by upgrading the windshield, front side windows, and front door panels. Alternatively, a streamlined configuration focused solely on the ballistic windshield remains a strong protective option, delivering substantial mitigation against the most common and highest-risk frontal ballistic threats.

#### **Problem Statement :**

Galveston County law enforcement officers face increasing threats from armed offenders, high-risk pursuits, and targeted ambushes. FBI LEOKA data continues to show a nationwide increase in officers assaulted with firearms, with a significant portion occurring in or around patrol vehicles.



Local agencies, including the Sheriff's Office and Constables, frequently engage in proactive enforcement and warrant service that exposes officers to elevated risk. Most patrol vehicles currently lack ballistic protection, leaving officers vulnerable during attacks. The absence of bullet-resistant components reduces survivability and limits the ability to effectively respond during ambush or firearm-based assaults.

### **Supporting Data :**

The Galveston County Sheriff's Office responded to over 120 high-risk incidents in 2023 involving armed suspects, barricaded subjects, or violent offenders. More than 2,500 vehicle-based enforcement stops are conducted annually, often involving unknown or potentially armed individuals. Texas reported over 50 firearm assaults on peace officers in 2023, according to TCOLE, representing a 15% increase from 2022. FBI LEOKA statistics further confirm that vehicle ambushes and traffic stop shootings are among the most fatal encounters for officers. These trends underscore the urgent need for enhanced ballistic protection to mitigate risks to law enforcement personnel.

### **Project Approach & Activities:**

This project will install NIJ Level IIIA-rated ballistic components in 88 Galveston County law enforcement vehicles. The scalable approach ensures effective use of grant funds based on award size: • Full "DPS" Ballistic Package: Includes windshield, front side windows, and door panels • Windshield-Only Option: Provides ballistic protection for the most exposed area of patrol vehicles Implementation Phases: 1. Procurement: Competitive bid process following county and OOG procurement requirements. 2. Installation: Conducted by certified vendors or through GCSO Fleet Services coordination. 3. Verification: Post-installation inspections and certification of ballistic standards compliance. The project ensures measurable officer safety enhancement even if partial funding allows only the windshield option.

### **Capacity & Capabilities:**

The Galveston County Sheriff's Office (GCSO) will lead this initiative through its Fleet Services Division, which manages all county law enforcement vehicles. GCSO and partner agencies—including the four Constable precincts and the District Attorney's Office Investigative Division—have successfully implemented state and federal equipment grants and maintain established procurement, audit, and reporting processes. Collectively, these agencies employ over 250 certified peace officers serving more than 370,000 residents across 873 square miles.

### **Performance Management :**

Performance will be measured through: • Outputs: Number of vehicles equipped with ballistic protection. • Outcomes: Reduced officer vulnerability during firearms-related assaults. • Verification: Procurement records, installation certifications, and before/after photographs. The GCSO Administrative Captain will oversee quarterly progress reports submitted to the County Grants Coordinator for final review and reporting to the Texas Office of the Governor.

### **Target Group :**

The project serves all sworn personnel assigned to patrol, investigations, and warrant service within the Galveston County Sheriff's Office, Constable Precincts 1–4, and the Criminal District Attorney's Office Investigative Division. The ballistic enhancements will protect frontline officers engaged in daily operations, ensuring consistent officer safety standards across all county jurisdictions.

### **Evidence-Based Practices:**

Studies from the National Institute of Justice (NIJ) and FBI LEOKA confirm that ballistic-resistant vehicle panels dramatically reduce fatal injuries during shootings and ambushes. NIJ Level IIIA-rated glass and armor are proven to stop handgun rounds up to .44 Magnum—the most frequent



firearm threat in law enforcement incidents. Previous DPS and county-level implementations of ballistic upgrade programs have resulted in documented increases in officer survivability and morale. By adopting a scalable, evidence-based model, Galveston County ensures both fiscal responsibility and maximum officer protection within available funding.

Galveston County ensures compliance through strict internal controls and continuous oversight.
