**Agreement by and between  
County of Galveston and Alliant Insurance Services, Inc.  
Relating to Medical Inmate Healthcare Services**

**Parties**

This Agreement for Consulting Services (the "Agreement") is made and entered into by and between the County of Galveston, a political subdivision of the State of Texas, acting by and through its Galveston County Commissioners Court (the "County"), and **Alliant Insurance Services, Inc.**, a California corporation (the "Consultant"), each of whom is a Party hereto and who are collectively referred to herein as the Parties.

**Services**

Provide an overview of medical inmate healthcare services, along with an assessment of the current program, and negotiate an agreement with the University of Texas Medical Branch at Galveston (UTMB) for medical inmate healthcare services.

**Compensation**

The County shall compensate the Consultant for services performed under this Agreement in an amount not to exceed \$10,000.00. No revisions in the maximum amount payable will be permitted unless previously authorized in writing by the County. Payments for authorized services will be made by the County upon presentation of an invoice by the Consultant to the County reflecting the Consultant's performance of such services.

**Terms**

This Agreement shall be effective upon execution by the County and by the Consultant and shall remain in force until satisfactory completion of all services described.

**Termination**

Either party may terminate the Agreement with or without cause, or for convenience by giving at least thirty (30) calendar days advance notice in writing.

**Venue and Choice of Law**

This Agreement shall be construed and enforced for all purposes pursuant to the laws of the State of Texas. Venue shall lie exclusively in a court of competent jurisdiction in Galveston County, Texas.

This Agreement inures only to the benefit of Galveston County and Contractor. This Agreement does not create, is not intended to create, and shall not be deemed or construed to create, any rights or benefits in third parties.
