





**Agreement for lodging/sleep accommodations Between  
The County of Galveston and Hampton Inn and Suites**

This Agreement is entered into by and between the County of Galveston, a political subdivision of the State of Texas, and Hampton Inn and Suites. The Agreement is as follows:

**1. Intent and Objective**

The purpose of this Agreement is to provide lodging/sleeping accommodations as needed by the employees of Galveston County who are activated to directly support emergency disaster operations. Priority is for Tier 1 activated employees who cannot return to their homes due to severe weather, road closures, damage to homes, and other extreme situations.

**2. Galveston County Office of Emergency Management**

Galveston County has established the Office of Emergency Management (OEM). This office is responsible for programs dealing with emergency and disaster mitigation, planning, preparedness, response, and recovery. It is also responsible for the establishment, maintenance, and operation of the Galveston County Emergency Operations Center (EOC). As such the Emergency Management Coordinator of Galveston County OEM will be the designated representative for the County of Galveston to manage this agreement.

**3. Hampton Inn and Suites Responsibility**

The facility provides lodging accommodations at 2320 Gulf Freeway South, League City, TX 77573 is approximately 1.5 miles north of the Galveston County Emergency Management Facility, which is located at 1353 FM 646 West, League City, TX 77573 (Exit 20 from Interstate 45).

Hampton Inn and Suites agrees to set aside a block of rooms, 5-10 rooms, to support Galveston County EOC personnel during a disaster.

Hampton Inn and Suites will honor the seasonal government rate for the block of rooms at the time of request for the rooms.

Hampton Inn and Suites agrees to provide itemized statements/receipts for rooms reserved and paid by the County of Galveston via purchase card.

**4. County Responsibility**

Galveston County OEM will be required to call and reserve the rooms 5 to 7 days in advance of the approaching storm.

Galveston County OEM will be required to cancel any and/or all reserved rooms no later than 24 hours before the storm makes landfall to allow the hotel to open the reservations to the general public.

Galveston County personnel will be required to provide credentials, a county ID badge, for verification of employment with the county, and a hotel authorization form attached as Exhibit 1.

Galveston County will pay reservations via a purchase card with the MasterCard logo.

**5. Governing Law**

This agreement shall be governed by the law of the State of Texas, without regard to its choice of law principles, and all obligations of the parties are performable in Galveston, Texas. Venue shall lie exclusively in Galveston, Texas.

**6. Term**

This agreement shall commence on the date of execution hereof and shall continue for a one-year term. Either Party may terminate this Agreement upon thirty (30) days prior written notice of the Party desiring to terminate being given to the other Party.

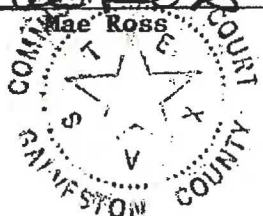
